EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1013

Affirmed Ineligible Weeks 29-23 through 30-23

PROCEDURAL HISTORY: On August 3, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of July 16, 2023 through July 22, 2023 (week 29-23) and until the reason for the denial had ended. Claimant filed a timely request for hearing. On August 24, 2023, ALJ Adamson conducted a hearing, and on August 29, 2023, issued Order No. 23-UI-234471, modifying the August 3, 2023 administrative decision by concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive benefits for the weeks of July 16, 2023 through July 29, 2023 (weeks 29-23). On September 6, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's argument in reaching this decision. It should be noted that testimony was offered at hearing that the Department originally determined that claimant was ineligible to receive benefits for weeks 29-23 through 30-23 for two separate reasons: that she failed to provide information to verify her identity in accordance with the Department's rules, and that she failed to register for work in accordance with the Department's rules. Transcript at 10. In order to receive benefits for any week, a claimant must not be ineligible for any reason. The Department's representative testified that they were withdrawing the administrative decision alleging ineligibility regarding identity verification. Transcript at 11-12. Accordingly, claimant may not have been ineligible for benefits for weeks 29-23 through 30-23 as to the identity verification issue. However, claimant remained ineligible for benefits for those weeks based on her failure to register for work as required, as alleged in the August 3, 2023, administrative decision. Only claimant's ineligibility for benefits based on her failure to register for work is at issue in this appeal, and must be decided independently of any other eligibility determination. Since this decision affirms that claimant was ineligible for benefits for weeks 29-23 through 30-23 because she failed to register for work in accordance with the Department's rules, she is not entitled to benefits for those weeks regardless of whether the Department withdrew the other administrative decision regarding identity verification.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-234471 is affirmed.
