EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1016

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 17, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 105130). On November 7, 2022, decision # 105130 became final without the employer having filed a request for hearing. On November 9, 2022, the employer filed a late request for hearing. ALJ Kangas reviewed the employer's request, and on April 12, 2023 issued Order No. 23-UI-221862, dismissing the request as late, subject to the employer's right to renew the request by responding to an appellant questionnaire by April 26, 2023. On May 2, 2023, Order No. 23-UI-221862 became final without the employer having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On May 16, 2023, the employer filed a late response to the appellant questionnaire and a late application for review of Order No. 23-UI-221862. On September 11, 2023, ALJ Kangas mailed a letter to the employer stating that because the appellant questionnaire response was late, it would not be considered and a new order would not be issued. This matter comes before EAB based on the employer's May 16, 2023 late application for review of Order No. 23-UI-221862.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement accompanying the employer's late application for review, which is the employer's appellant questionnaire response, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-221862, mailed to the employer on April 12, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-221862 at 2. Order No. 22-UI-221862 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than May 2, 2023."

CONCLUSION AND REASONS: The employer's late application for review of Order No. 23-UI-221862 is dismissed.

An application for review to EAB is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-221862 was due May 2, 2023. Because the employer did not file their application for review until May 16, 2023, the application for review was late. The employer provided a written statement with their late application for review, which was their response to the appellant questionnaire. *See* EAB Exhibit 1. In their response, the employer's one, part-time human resources administrator asserted that the application for review was late because they were absent due to illness for two weeks, and upon their return in "May" had a "pile of work." EAB Exhibit at 6.

While the employer's staff outage may explain why the application for review was late, the employer has not shown that the delay in filing the application for review was due to a circumstance beyond their reasonable control. The employer apparently had a "pile of work" that was assigned to the human resources administrator to review and complete after having accumulated while they were absent due to illness. However, the employer's information does not show that it was beyond their reasonable control to assign some work to an owner or other employee rather than let it accumulate, to review the mail for urgent matters, or to prioritize the order in which staff completed their work. Because the employer's choice not to take reasonable measures to prioritize the timely filing of the application for review was not a circumstance beyond their reasonable control that prevented a timely filing, the employer has not shown good cause to extend the deadline to file their application for review. Accordingly, the employer's late application for review must be dismissed.

DECISION: The application for review filed May 16, 2023 is dismissed. Order No. 23-UI-221862 remains undisturbed.
