EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1017

Affirmed No Disqualification

PROCEDURAL HISTORY: On September 3, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was therefore disqualified from receiving unemployment insurance benefits effective August 15, 2021 (decision # 160128). Claimant filed a timely request for hearing. On March 1, 2023, ALJ L. Lee conducted a hearing, and on March 10, 2023 issued Order No. 23-UI-218610, reversing decision # 160128 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On March 24, 2023, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider the employer's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

The employer also requested to reopen the hearing pursuant to OAR 471-040-0040 (February 10, 2012) to offer testimony from the employer's owner and "[several] other witnesses," asserting that they were unable to appear at the hearing because weather conditions made them inaccessible by telephone. The Employer's Written Argument at 1. OAR 471-040-0040(1)(a) provides that a party may only request reopening of a hearing if the party requesting the reopening "failed to appear at the hearing." Big Bark Chipper Service is the employer, and is therefore a party in this case. Neither the business's owner, in the owner's personal capacity, nor any other individuals involved with that business are parties in the case. The employer appeared at the hearing represented by their office manager. Audio Record at 0:13. Therefore, the employer may not request reopening of the hearing, since the employer did not fail to appear at the hearing.

Instead, the employer's request is properly characterized as an offer of information not in the hearing record, in the form of testimony from witnesses who were unavailable to testify at the hearing. The employer has not shown that factors or circumstances beyond the employer's reasonable control prevented the employer from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). The employer's representative at the hearing could have requested a continuance

based on the witnesses' unavailability, but did not do so, and told the ALJ that she did not intend to call any witnesses other than herself. Audio Record at 1:16. Accordingly, while these potential witnesses may have been unavailable to testify due to factors beyond their reasonable control, the employer was not prevented from *offering* the information known to these potential witnesses by telling the ALJ about the witnesses and requesting that accommodations, such as a continuance, be made to allow them to testify. Therefore, pursuant to OAR 471-041-0090, the information now offered by these witnesses cannot be considered. EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-218610 is affirmed.
