

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1026

Affirmed
Request for Hearing Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 31, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective March 12, 2023 (decision # 94909). Claimant filed a timely request for hearing. On May 5, 2023, claimant withdrew her request for hearing in writing. On September 5, 2023, ALJ Sachet-Rung issued Order No. 23-UI-235082, dismissing claimant’s request for hearing based on claimant’s request to withdraw her request. On September 8, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant submitted written arguments on September 8 and 11, 2023. However, claimant did not declare that she provided a copy of her arguments to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The arguments also contained information, including documents regarding claimant’s health and documents directed to the “Speech/Language Board,” that is not relevant to EAB’s determination of whether claimant withdrew her request for hearing on decision # 94909. *See* OAR 471-041-0090 (May 13, 2019). EAB therefore did not consider claimant’s written arguments when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-235082 is affirmed.
