# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1036

#### Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On October 28, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the weeks from April 26, 2020 through May 1, 2021 (weeks 18-20 through 17-21) because they did not file timely claims for benefits for those weeks (decision # 115800). Claimant filed a timely request for hearing. On December 15, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for December 29, 2022. On December 29, 2022, claimant failed to appear at the hearing, and on December 30, 2022 ALJ Lucas issued Order No. 22-UI-211364, dismissing claimant's request for hearing due to their failure to appear. On January 11, 2023, claimant filed a timely request to reopen the hearing. On August 4, 2023, OAH served notice of a hearing scheduled for August 18, 2023 on whether to allow claimant's request to reopen the hearing, and on August 22, 2023 issued Order No. 23-UI-233917, allowing claimant's request to reopen, but affirming decision # 115800. On September 11, 2023, Order No. 23-UI-233917 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On September 12, 2023, claimant filed a late application for review with EAB.

**FINDING OF FACT:** (1) Order No. 23-UI-233917, mailed to claimant on August 22, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-233917 at 4. Order No. 23-UI-233917 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before September 11, 2023 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 23-UI-233917 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-

0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-233917 was due September 11, 2023. Because claimant did not file their application for review until September 12, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented them from filing the application for review by the September 11, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and their late application for review is dismissed.

**DECISION:** The application for review filed September 12, 2023 is dismissed. Order No. 23-UI-233917 remains undisturbed.
