EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1041

Affirmed
Overpayment Waiver Denied

PROCEDURAL HISTORY: On August 4, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's requests for regular unemployment insurance (regular UI), Extended Benefits (EB), and Pandemic Emergency Unemployment Compensation (PEUC) overpayment waivers (decision # 143201). Claimant filed a timely request for hearing. On August 23, 2023, ALJ Blam conducted a hearing, and on August 31, 2023, issued Order No. 23-UI-234810, modifying¹ decision # 143201 by denying claimant's request for Federal Pandemic Unemployment Compensation (FPUC) and PEUC waivers. On September 14, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-234810 is affirmed.

¹ Although Order No. 23-UI-234810 stated that it affirmed decision # 143201, it modified that decision by concluding that claimant's waiver request was denied as to claimant's overpayments of PEUC and FPUC benefits, whereas decision # 143201 purported to deny claimant's waiver request as to his overpayments of regular UI benefits, EB benefits, and PEUC benefits. Waiver of overpayment of regular UI and EB benefits were not at issue at the August 23, 2023 hearing. The order concluded, "The Employment Department should not grant the claimant's request for a waiver of the FPUC or PEUC benefit overpayments. Claimant is now obligated to repay the benefits in the amount of \$10,236.00." Order No. 23-UI-234810 at 5. However, the repayment amount listed in the order is a scrivener's error. \$10,236 is the amount of the combined regular UI benefits and EB. Transcript at 8-9, 12. The PEUC overpayment amount is \$5,712. The FPUC overpayment amount is \$9,900. The overpayment amount of PEUC and FPUC payments combined is \$15,612. Transcript at 11.
