## EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1042

Affirmed
Request to Reopen Allowed
Overpayments Assessed

**PROCEDURAL HISTORY:** On November 24, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$200 in Pandemic Emergency Unemployment Compensation (PEUC) and \$800 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which she was not entitled and must repay (decision # 114408). Also on November 24, 2022, the Department served notice of an administrative decision concluding that claimant received \$900 in FPUC benefits to which she was not entitled and must repay (decision # 102201). Claimant filed timely requests for hearing on decisions # 114408 and 102201. On June 27, 2023, notice was mailed to claimant that hearings on decisions # 114408 and 102201 were scheduled for July 14, 2023. On July 14, 2023, claimant failed to appear at the hearings, and ALJ Janzen issued Orders No. 23-UI-230521 and 23-UI-230523, dismissing claimant's requests for hearing due to her failure to appear. On July 26, 2023, claimant filed a timely request to reopen the July 14, 2023, hearings. On September 5, 2023, ALJ Janzen conducted a hearing, and on September 6, 2023, issued Orders No. 23-UI-235141 and 23-UI-235145, allowing claimant's request to reopen the July 14, 2023, hearings and affirming decisions # 114408 and 102201. On September 14, 2023, claimant filed applications for review of Orders No. 23-UI-235141 and 23-UI-235145 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-235141 and 23-UI-235145. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1042 and 2023-EAB-1043).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing record and was not relevant to EAB's determination of whether claimant was overpaid benefits. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-235141 and 23-UI-235145 are affirmed.
