

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1046**

*Application for Review Dismissed*  
*No Justiciable Controversy*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On March 10, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective August 15, 2021 (decision # 133751). Claimant filed a timely request for hearing. On April 13, 2022, ALJ Murdock conducted a hearing, and on April 18, 2022, issued Order No. 22-UI-191607, modifying decision # 133751 by concluding that claimant was disqualified from receiving benefits effective August 22, 2021. On April 25, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

On July 13, 2022, EAB issued EAB Decision 2022-EAB-0506, reversing Order No. 22-UI-191607 and remanding the matter for further proceedings. On August 16, 2023, ALJ Monroe conducted a hearing, and on August 29, 2023, issued Order No. 23-UI-234587, reversing decision # 133751 by concluding that claimant quit work with good cause and was not disqualified from receiving benefits as a result of the work separation. On September 16, 2023, claimant filed an application for review of Order No. 23-UI-234587 with EAB.

**WRITTEN ARGUMENT:** EAB did not consider claimant's written argument when reaching this decision because he did not include a statement declaring that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

**CONCLUSIONS AND REASONS:** Claimant's application for review of Order No. 23-UI-234587 presents no justiciable controversy and is dismissed.

On September 16, 2023, claimant filed with EAB an application for review of an order that allowed the appellant benefits based on the work separation. Claimant assigned error to the portion of that order characterizing the work separation as a voluntary leaving. However, as the order under review concluded that claimant was not disqualified from receiving unemployment insurance benefits based on the work separation, he has not alleged error that would entitle him to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for

review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review is dismissed and Order No. 23-UI-234587 remains undisturbed.

**DECISION:** The application for review filed September 16, 2023, is dismissed. Order No. 23-UI-234587 remains undisturbed.
