

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1051**

*Affirmed*  
*Ineligible for Benefits Weeks 14-21 through 26-21*

**PROCEDURAL HISTORY:** On September 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work for the weeks including April 4, 2021, through July 3, 2021 (weeks 14-21 through 26-21) and was therefore not eligible to receive unemployment insurance benefits for those weeks (decision # 83141). On October 4, 2021, decision # 83141 became final without claimant having filed a request for hearing. On July 18, 2022, claimant filed a late request for hearing. On August 29, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for September 12, 2023, on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 83141. On September 12, 2023, ALJ Enyinnaya conducted a hearing, and on September 14, 2023, issued Order No. 23-UI-235849, concluding that claimant's request for hearing was late, but with good cause, and affirming decision # 83141 on the merits. On September 18, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-235849 is affirmed.
