EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1061

Affirmed No Disqualification

PROCEDURAL HISTORY: On April 20, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged, but not for misconduct, and was therefore not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 94613). The employer filed a timely request for hearing. On August 28, 2023, ALJ Blam conducted a hearing, and on September 1, 2023 issued Order No. 23-UI-234933, affirming decision # 94613. On September 21, 2023, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered the employer's argument in reaching this decision.

The employer argued that claimant's March 24, 2023 email to a human resources representative "alleges her direct supervisor violated the NASW (licensing body) code of ethics and cited section 3.0 in the NASW Ethical Guidelines." The Employer's Written Argument at 2. According to the employer, making such an allegation without "a substantive explanation as to what the ethical violation was or proof to support the allegation" violated the employer's expectation that "[a]ny allegations of inappropriate behavior [made by claimant] will be provided along with evidence that supports said allegation." The Employer's Written Argument at 2; Exhibit 1 at 7. The record does not support the employer's characterization of the March 24, 2023 email as containing allegations by claimant against another person.

Claimant wrote in the email, "Additionally, the 'maintain a positive atmosphere among colleagues while in the work environment," what I am being reprimanded for contradicts the NASW Code of Ethics, particularly in section 3.09 Commitments to Employers which states in section b, *Social Workers should work to improve employing agencies' policies and procedures and effectiveness of their services.*" Exhibit 1 at 5 [italics in original]. Claimant's statement only expressed that she believed the quoted directive from her performance improvement plan (PIP) conflicted with *claimant's* ethical duty under section 3.09 to work to improve the employer's policies and procedures and effectiveness of services, presumably by offering feedback to the employer that might not always be considered "positive." This

statement did not allege that claimant's *supervisor* or any other person violated an ethical duty under section 3.09 or any other policy or rule, as the employer contended. The rest of the email detailed claimant's other reasons for disagreeing with the imposition of the PIP, and while her supervisor was mentioned by name in several instances, it was only in the context of disputing the supervisor's allegations against claimant in the PIP, rather than claimant making allegations of her own against her supervisor. Because the employer has not shown that claimant made an allegation of inappropriate behavior by another in her March 24, 2023 email, they failed to prove that claimant was discharged for violating their expectation that she refrain from making allegations without evidence. The record therefore supports the order's conclusion that the employer discharged claimant, but not for misconduct.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-234933 is affirmed.
