

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1074**

*Affirmed*  
*Ineligible Weeks 31-23 and 32-23*

**PROCEDURAL HISTORY:** On August 16, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the week of July 30 through August 5, 2023 (week 31-23) and until claimant registered for work following the rules set by the Department. On August 18, 2023, the Department served notice of an administrative decision concluding that claimant was denied benefits for the weeks from July 30 through August 12, 2023 (weeks 31-23 and 32-23) and until claimant provided ID verification documentation following the rules set by the Department (decision # 103020). Claimant filed a timely request for hearing on both administrative decisions. On September 14, 2023, ALJ Scott conducted a hearing on both administrative decisions. On September 20, 2023, ALJ Scott issued Order No. 23-UI-236268, modifying the August 16, 2023 administrative decision by concluding that claimant was ineligible for benefits for weeks 31-23 and 32-23. Also on September 20, 2023, ALJ Scott issued Order No. 23-UI-236267, affirming decision # 103020.

On September 26, 2023, claimant filed an application for review of Orders No. 23-UI-236268 and 23-UI-236267 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-236268 and 23-UI-236267. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1075 and 2023-EAB-1074).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Order Nos. 23-UI-236268 and 23-UI-236267 are affirmed.
