# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1077

Late Application for Review Dismissed Without Prejudice

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On February 28, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request to backdate his initial claim to September 25, 2022, and concluding that claimant therefore was not eligible for benefits for the week of September 25 through October 1, 2022 (week 39-22) (decision # 135741). Claimant filed a timely request for hearing. On May 3, 2023, ALJ Frank conducted a hearing, and on May 11, 2023 issued Order No. 23-UI-224630, affirming decision # 135741. On May 31, 2023, Order No. 23-UI-224630 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On September 27, 2023, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of an emailed statement dated September 27, 2023, which has been construed as claimant's application for review; as well as a follow-up email dated October 6, 2023. This evidence has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

Claimant also enclosed a letter from the Department, dated February 22, 2023, with his application for review. This letter was not part of the hearing record, and claimant did not show that the letter was relevant and material to EAB's determination of whether claimant's late application for review should be allowed. Under OAR 471-041-0090(1)(b)(A), and excepting the contents of EAB Exhibit 1, above, EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On September 27, 2023, the appellant filed an application for review of Order No. 23-UI-224630 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later

than May 31, 2023. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is November 3, 2023, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that he sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason he filed a late application for review. For example, the appellant should include specific information about the date he received the ALJ's order, whether he read it, whether he agreed or disagreed with the ALJ's order, the reason(s) why he did not file the application for review before the deadline, how the reason(s) affected his ability to file a timely application for review, when they "tried to submit another appeal in May [2023]" to the Office of Administrative Hearings (OAH) and by what means, and any other specific details that might help EAB determine whether the appellant filed a timely application for review, or not the appellant had "good cause," which means factors or circumstances beyond his reasonable control prevented him from filing a timely application for review, *and*
- 4. The appellant must provide the date the circumstances that prevented him from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that he filed the application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: <u>https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx</u>, *or*
- 2. Use your smart phone, tablet, or computer to send an email to EAB at <u>OED\_EAB\_OFFICE@employ.oregon.gov</u>, *or*
- 3. Send the request by U.S. mail or another delivery service, addressed to 875 Union St NE, Salem, Oregon 97311, *or*
- 4. Send EAB a fax at 503-378-2129.

**DECISION:** The application for review filed September 27, 2023 is dismissed without prejudice. Order No. 23-UI-224630 remains undisturbed.
