

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1078

Affirmed
No Disqualification

PROCEDURAL HISTORY: On December 20, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective October 2, 2022 (decision # 150822). Claimant filed a timely request for hearing. On February 15, 2023, ALJ Nyberg conducted a hearing, and on February 23, 2023 issued Order No. 23-UI-216944, affirming decision # 150822. On March 8, 2023, claimant filed an application for review with the Employment Appeals Board (EAB). On April 18, 2023, EAB issued EAB Decision 2023-EAB-0295, remanding the matter back to the Office of Administrative Hearings (OAH) for further development of the record to determine if claimant quit work without good cause.

On May 22, 2023, OAH served notice of a hearing scheduled for June 5, 2023. On June 5, 2023, claimant failed to appear at the remand hearing, and ALJ Nyberg issued Order No. 23-UI-226963, dismissing claimant's request for hearing due to his failure to appear. On June 8, 2023, claimant filed a request to reopen the hearing. On July 6, 2023, OAH served notice of a hearing scheduled for July 18, 2023. On July 18, 2023, ALJ Nyberg conducted a hearing that was continued to September 12, 2023, and on September 20, 2023 issued Order No. 23-UI-236347, setting aside Order No. 23-UI-226963 and concluding that claimant had good cause for reopening the June 5, 2023 remand hearing, and reversing decision # 150822 by concluding that claimant quit work with good cause and was not disqualified from receiving benefits based on the work separation. On September 25, 2023, the employer filed a timely application for review of Order No. 23-UI-236347 with EAB.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-236347 is affirmed.
