

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1079-R

Request for Reconsideration Dismissed
EAB Decision 2023-EAB-1079 Remains Undisturbed

PROCEDURAL HISTORY: On May 23, 2023, the Oregon Employment Department (the Department) issued an administrative decision concluding that claimant had been receiving retirement pay that would reduce his weekly benefit amount by \$357 for the weeks including May 7, 2023, through May 20, 2023 (weeks 19-23 through 20-23) and until the reason for the deduction in benefits had ended (decision # 110605). Claimant filed a timely request for hearing. On August 1, 2023, ALJ L. Lee conducted a hearing at which the employer failed to appear, and on August 9, 2023, issued Order No. 23-UI-232740, affirming decision # 110605. On August 14, 2023, claimant filed an application for review with the Employment Appeals Board (EAB). On October 4, 2023, EAB issued EAB Decision 2023-EAB-1079, affirming Order No. 23-UI-232740. On October 4, 2023, claimant filed a request for reconsideration with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration is dismissed.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB issued EAB Decision 2023-EAB-1079 on October 4, 2023. Claimant filed his request for reconsideration on October 4, 2023, less than 20 days after EAB Decision 2023-EAB-1079 was mailed. However, claimant's request for reconsideration did not include any statement that claimant provided a copy of the request for reconsideration to the employer as required. Claimant's request is therefore dismissed.

DECISION: The application for review filed October 4, 2023, is dismissed. Order No. 23-UI-232740 remains undisturbed.
