

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1080

Affirmed
Overpayment of \$331 in Regular UI Benefits and \$300 in FPUC Benefits Assessed

PROCEDURAL HISTORY: On June 30, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was paid unemployment insurance benefits to which she was not entitled and assessing an overpayment of \$4,303 in regular unemployment insurance (regular UI) benefits and \$3,900 in Federal Pandemic Unemployment Compensation (FPUC) benefits that she was liable to repay the Department (decision # 154910). Claimant filed a timely request for hearing. On September 12, 2023, ALJ Mott conducted a hearing, and on September 20, 2023 issued Order No. 23-UI-236244, modifying decision # 154910 by concluding that the Department did not have authority to amend the original decisions allowing benefits for the weeks of April 4, 2021 through June 26, 2021 (weeks 14-21 through 25-21) or assess an overpayment for those weeks but was liable for an overpayment of \$331 in regular UI benefits and \$300 in FPUC benefits to be repaid to the Department by deduction from future benefits payable. On September 29, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-236244 is affirmed.
