

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1081

Affirmed
Overpayment, No Penalties

PROCEDURAL HISTORY: On September 9, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which she was not entitled, and assessing an overpayment of \$757 in regular unemployment insurance (regular UI) benefits and \$3,000 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision # 140716). Claimant filed a timely request for hearing. On September 18, 2023, ALJ Lewis conducted a hearing, and on September 19, 2023, issued Order No. 23-UI-236153, affirming decision # 140716. On September 28, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.¹

DECISION: Order No. 23-UI-236153 is affirmed.

¹ The record at hearing and the Department's claim records suggests that claimant's federal and regular UI overpayment balances at issue in this matter have been waived entirely, leaving claimant with no liability to repay the Department. While this decision affirms the conclusion of the order under review that the overpayments were properly *assessed*, it should not be construed in such a way as to reverse or otherwise affect any waivers of those overpayments that the Department has already granted, or may grant, claimant.
