# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1082

#### Reversed & Remanded

**PROCEDURAL HISTORY:** On February 15, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from January 22 through February 4, 2023 (weeks 04-23 through 05-23) and until the reason for the denial had ended (decision # 141944). On March 7, 2023, decision # 141944 became final without claimant having filed a request for hearing. On March 9, 2023, claimant filed a late request for hearing on decision # 141944. ALJ Kangas considered claimant's request, and on July 13, 2023 issued Order No. 23-UI-230320, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 27, 2023. On July 31, 2023, claimant filed a late request for review of Order No. 23-UI-230320 with the Employment Appeals Board (EAB). On August 8, 2023, ALJ Kangas mailed a letter to claimant stating that because the appellant questionnaire response was filed late, it would not be considered, and another order would not be issued. This matter comes before EAB based upon claimant's August 2, 2023 application for review.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's appellant questionnaire response and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** On February 15, 2023, the Department mailed decision # 141944 to claimant at claimant's address of record on file with the Department. Decision # 141944 stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received no later than March 7, 2023." Exhibit 1 at 2. Claimant filed their request for hearing on March 9, 2023.

**CONCLUSIONS AND REASONS:** Order No. 23-UI-230320 is set aside, and this matter remanded for a hearing to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # 141944.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The deadline to file a request for hearing on decision # 141944 was March 7, 2023. Claimant filed their request for hearing on March 9, 2023. Therefore, the request for hearing was late.

Claimant's questionnaire response asserted that they spoke on the phone with a Department representative regarding their disagreement with decision # 141944 and were advised to call a different number "for an appeals agent," which they called, leaving a voicemail. EAB Exhibit 1 at 1. Claimant contended that their appeal was filed late because they were awaiting a response to that voicemail. EAB Exhibit 1 at 2. If claimant was given erroneous or misleading information by a Department representative on how they could file a request for hearing, this may have constituted an excusable mistake that prevented timely filing of their request for hearing. Further development of the record is therefore needed.

On remand, inquiry should be made into when claimant made these calls to the Department; whether claimant thought they had filed a request for hearing as a result of making these calls, and if not, why other action was not taken to file a request for hearing prior to the deadline; and whether any other factor prevented timely filing of the request for hearing.

For these reasons, Order No. 23-UI-230320 is set aside, and the matter remanded for a hearing to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # 141944.

**DECISION:** Order No. 23-UI-230320 is set aside, and this matter remanded for further proceedings consistent with this order.
