EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1085

Affirmed
Ineligible Weeks 26-20 and 31-20

PROCEDURAL HISTORY: On December 11, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from June 21 through 27, 2020 (week 26-20) and was not eligible for benefits for that week (decision # 92528). Also on December 11, 2020, the Department served notice of an administrative decision concluding that claimant was not available for work from July 26 through August 1, 2020 (week 31-20) and was not eligible for benefits for that week (decision # 93009). On December 31, 2020, decisions # 92528 and 93009 became final without claimant having filed a request for hearing. On April 20, 2022, claimant filed late requests for hearing. ALJ Kangas considered claimant's requests, and on August 2, 2022, issued Orders No. 22-UI-199557 and No. 22-UI-199555, dismissing the requests as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by August 16, 2022. On August 5, 2022, claimant filed a timely response to the appellant questionnaire.

On October 19, 2022, the Office of Administrative Hearings (OAH) mailed letters stating that Orders No. 22-UI-199557 and No. 22-UI-199555 were vacated and that hearings would be scheduled to determine whether to allow claimant's late requests for hearing and, if so, the merits of decisions # 92528 and 93009. On September 13, 2023, ALJ Sachet-Rung conducted a hearing on decision # 92528, and on September 19, 2023, issued Order No. 23-UI-236168, allowing claimant's late request for hearing on decision # 92528 and affirming decision # 92528. On September 21, 2023, ALJ Kaneshiro conducted a hearing on decision # 93009, and on September 22, 2023, issued Order No. 23-UI-236585, allowing claimant's late request for hearing on decision # 93009 and affirming decision # 93009. On September 29, 2023, claimant filed applications for review of Orders No. 23-UI-236168 and 23-UI-236585 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-236168 and 23-UI-236585. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1084 and 2023-EAB-1085).

WRITTEN ARGUMENT: Claimant did not declare that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also

contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-236168 and 23-UI-236585 are affirmed.
