EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1088

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 31, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied unemployment insurance benefits beginning January 22, 2023, because he was discharged by the employer for misconduct (decision # 83626). Claimant filed a timely request for hearing. On September 5, 2023, ALJ Micheletti conducted a hearing, and on September 6, 2023, issued Order No. 23-UI-235138, reversing decision # 83626 by concluding that claimant's discharge was not for misconduct and did not disqualify claimant from receiving benefits. On September 26, 2023, Order No. 23-UI-235138 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On September 29, 2023, the employer filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the envelope in which the employer mailed their application for review, which has been marked as EAB Exhibit 1, and the written statement the employer included with their application for review, which has been marked as EAB Exhibit 2. Copies of EAB Exhibits 1 and 2 have been provided to the parties with this decision. Any party that objects to our admitting EAB Exhibits 1 and/or 2 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibits will remain in the record.

FINDINGS OF FACT: (1) Order No. 23-UI-235138, mailed to claimant on September 6, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-235138 at 3. Order No. 23-UI-235138 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before September 26, 2023, to be timely."

(2) The employer filed their application for review of Order No. 23-UI-235138 by mail. The postmark date affixed to the envelope in which the application was mailed is September 29, 2023. EAB Exhibit 1.

(3) The employer included a written statement with their application for review. EAB Exhibit 2. The written statement did not explain why the application for review was not mailed in time for the envelope in which it was mailed to be post-marked on or before September 26, 2023. EAB Exhibit 2.

CONCLUSIONS AND REASONS: The employer's application for review of Order No. 23-UI-235138 was late and therefore is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-235138 was due September 26, 2023. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which the employer mailed their application for review was September 29, 2023. EAB Exhibit 1. That date is therefore the filing date. Because the employer did not file their application for review until September 29, 2023, the application for review was late. The employer provided a written statement with their application for review. EAB Exhibit 2. However, the written statement did not explain why the application for review was not filed on time. EAB Exhibit 2. Accordingly, the employer did not show good cause to extend the deadline for filing the application for review, and the late application for review is dismissed.

DECISION: The application for review filed September 29, 2023, is dismissed. Order No. 23-UI-235138 remains undisturbed.
