

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1090**

*Affirmed*  
*Ineligible Week 31-23*  
*Eligible Weeks 32-23 and 33-23*

**PROCEDURAL HISTORY:** On August 16, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to register as required by the Department's rules and was not eligible for benefits for the week of July 30 through August 5, 2023, and until the reason for the denial ended. On August 18, 2023, the Department served notice of an administrative decision concluding that claimant failed to provide information to the Department as required by the Department's rules and was not eligible for benefits for the weeks from July 30 through August 12, 2023, and until the reason for the denial ended (decision # 103834). Claimant filed timely requests for hearing on both administrative decisions. On September 25, 2023, ALJ Lewis conducted a hearing, and on September 28, 2023, issued Orders No. 23-UI-237168 and 23-UI-237123, modifying the August 16, 2023 administrative decision and decision # 103834 by concluding claimant was not eligible for benefits for the week of July 30 through August 5, 2023 (week 31-23), but was eligible for benefits for the weeks from August 6 through August 19, 2023 (weeks 32-23 through 33-23). On October 2, 2023, claimant filed applications for review of Orders No. 23-UI-237168 and 23-UI-237123 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-237168 and 23-UI-237123. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1090 and 2023-EAB-1091).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-237168 and 23-UI-237123 are affirmed.
