# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1094

Late Application for Review Allowed
Affirmed
Disqualification

**PROCEDURAL HISTORY:** On August 15, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective June 18, 2023 (decision # 124804). Claimant filed a timely request for hearing. On September 5, 2023, ALJ Lewis conducted a hearing, and on September 12, 2023, issued Order No. 23-UI-235618, affirming decision # 124804. On October 2, 2023, Order No. 23-UI-235618 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On October 4, 2023, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement provided with claimant's late application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**WRITTEN ARGUMENT:** EAB did not consider claimant's written argument when reaching this decision because she did not include a statement declaring that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a). However, claimant's written statement explaining why her application for review was filed late was considered as part of EAB Exhibit 1. In that statement, claimant asserted that the hearing proceedings were unfair or the ALJ was biased. EAB reviewed the hearing record in its entirety, which shows that the ALJ inquired fully into the matters at issue and gave all parties reasonable opportunity for a fair hearing as required by ORS 657.270(3) and (4) and OAR 471-040-0025(1) (August 1, 2004).

**FINDINGS OF FACT:** (1) Order No. 23-UI-235618, mailed to claimant on September 12, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-235618 at 3. Order No. 23-UI-235618 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 2, 2023, to be timely."

(2) Beginning September 5, 2023, claimant's daughter was ill and required constant care from claimant. Claimant's daughter was eventually hospitalized and remained in the hospital as of October 4, 2023. Additionally, claimant became ill during this time, and in the week preceding October 4, 2023, she was unable to get out of bed, affecting her ability to get mail.

**CONCLUSIONS AND REASONS:** Claimant's late application for review is allowed. Claimant quit work without good cause.

**Late application for review.** An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-235618 was due October 2, 2023. Because claimant did not file her application for review until October 4, 2023, the application for review was late.

Claimant wrote in the statement accompanying her late application for review that she and her daughter were suffering from severe ailments from the time of the hearing through October 4, 2023. EAB Exhibit 1 at 1. It is unclear from the statement whether these ailments prevented claimant from timely retrieving Order No. 23-UI-235618 from the mail, being able to file an application for review, or both. However, the record shows that claimant's medical condition and the need to attend to her daughter's medical condition were circumstances outside claimant's reasonable control that likely prevented her from timely filing an application for review for one or more of those reasons. Claimant further wrote that the circumstances that prevented timely filing ceased on October 4, 2023, when claimant's medical condition improved, and her daughter had been admitted to the hospital and was no longer relying on claimant for care. EAB Exhibit 1 at 3. Because claimant filed her application for review that day, she did so within a "reasonable time." Accordingly, claimant has shown good cause to extend the deadline for timely filing, and claimant's late application for review of Order No. 23-UI-235618 is allowed.

**Review of Order No. 23-UI-235618.** EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Claimant's late application for review is allowed. Order No. 23-UI-235618 is affirmed.
