EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1097

*Application for Review Dismissed
No Justiciable Controversy*

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 8, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing an overpayment of \$2,716 in regular unemployment insurance (regular UI) benefits, \$3,952 in Pandemic Emergency Unemployment Compensation (PEUC) benefits, \$2,400 in Federal Pandemic Unemployment Compensation (FPUC) benefits, and \$1,800 in Lost Wages Assistance (LWA) benefits that claimant was required to repay to the Department, a \$2,720.40 monetary penalty, and a 52-week penalty disqualification from future benefits. Claimant filed a timely request for hearing. On September 8, 2023, ALJ Lewis conducted a hearing, and on September 15, 2023 issued Order No. 23-UI-235974, affirming the September 8, 2022 administrative decision.¹ On October 5, 2023, the Department filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: The Department's application for review of Order No. 23-UI-235974 presents no justiciable controversy and is dismissed.

On October 5, 2023, the Department filed with EAB an application for review of an order that affirmed the Department's September 8, 2022 administrative decision. The Department did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling

¹ In affirming the September 8, 2022 administrative decision, Order No. 23-UI-235974 stated that claimant was required to repay overpayments of \$9,068 in "unemployment benefits" and \$1,800 in "FPUC benefits." Order No. 23-UI-235974 at 1. The reference to the \$1,800 overpayment as being FPUC benefits rather than LWA benefits is presumed to be a scrivener's error, as the order otherwise affirmed the September 8, 2022 administrative decision's conclusion that claimant was overpaid a total of \$9,068 in combined regular UI, PEUC, and FPUC benefits, and was also overpaid \$1,800 in LWA benefits.

the Department to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon the Department's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 23-UI-235974 is dismissed and the order remains undisturbed.

DECISION: The application for review filed October 5, 2023 is dismissed. Order No. 23-UI-235974 remains undisturbed.
