# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1100

Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On July 20, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning July 4, 2021, because they quit working for the employer without good cause (decision # 110841). On August 9, 2021, decision # 110841 became final without claimant having filed a request for hearing. On November 16, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on February 3, 2022, issued Order No. 22-UI-185504, dismissing that request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 17, 2022. Claimant filed a timely response to the appellant questionnaire.

On April 22, 2022, the Office of Administrative Hearings (OAH) mailed the parties a letter stating that based on claimant's response the appellant questionnaire, Order No. 22-UI-185504 was cancelled and vacated, and that a hearing would be scheduled on whether to allow claimant's late request for hearing and, if so, the merits of decision # 110841. On September 8, 2023, OAH served notice that the hearing was scheduled for September 22, 2023. On September 22, 2023, ALJ Enyinnaya conducted the hearing at which the employer did not appear, and on September 29, 2023, issued Order No. 23-UI-237246, allowing claimant's late request for hearing and reversing decision # 110841 by concluding that claimant quit working for employer with good cause and was not disqualified from receiving benefits based on the work separation. On October 4, 2023, claimant filed an application for review of Order No. 23-UI-237246 with the Employment Appeals Board (EAB).

**CONCLUSIONS AND REASONS:** Claimant's application for review of Order No. 23-UI-237246 presents no justiciable controversy and is dismissed.

On October 4, 2023, claimant filed with the Employment Appeals Board (EAB) an application for review of an order that allowed the appellant benefits. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995).

Because the case before EAB presents no justiciable controversy, the application for review of Order No. 23-UI-237246 is dismissed and Order No. 23-UI-237246 remains undisturbed.

**DECISION:** The application for review filed October 4, 2023, is dismissed. Order No. 23-UI-237246 remains undisturbed.
