

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1101

Affirmed
Late Request for Hearing on decision # 120315 Allowed
Ineligible for PEUC Benefits Weeks 53-20 through 30-21
Overpayment Assessed

PROCEDURAL HISTORY: On April 25, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was ineligible for Pandemic Emergency Unemployment Compensation (PEUC) benefits for the weeks from December 27, 2020, through July 31, 2021 (weeks 53-20 through 30-21) (decision # 120315). On May 16, 2022, decision # 120315 became final without claimant having filed a request for hearing. On July 26, 2022, the Department served notice of an administrative decision based in part on decision # 120315, concluding that claimant received \$7,254 in PEUC and \$5,400 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which he was not entitled and must repay (decision # 94840). On August 15, 2022, claimant filed a late request for hearing on decision # 120315 and a timely request for hearing on decision # 94840.

On September 13, 2023, ALJ Lewis conducted separate hearings on decisions # 120315 and 94840. On September 15, 2023, ALJ Lewis issued Order No. 23-UI-236022, allowing claimant's late request for hearing on decision # 120315 and affirming that administrative decision on the merits. On September 18, 2023, ALJ Lewis issued Order No. 23-UI-236101, affirming decision # 94840. On October 5, 2023, claimant filed applications for review of Orders No. 23-UI-236022 and 23-UI-236101 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-236022 and 23-UI-236101. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1102 and 2023-EAB-1101).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-236022 and 23-UI-236101 are affirmed.
