

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1110**

*Reversed & Remanded*

**PROCEDURAL HISTORY:** On January 6, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to actively seek work from December 11 through 24, 2022 (weeks 50-22 through 51-22) and was ineligible for benefits for those weeks (decision # 145517). On January 26, 2023, decision # 145517 became final without claimant having filed a request for hearing. On February 2, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on July 12, 2023, issued Order No. 23-UI-230249, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 26, 2023. On July 31, 2023, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 23-UI-230249 with the Employment Appeals Board (EAB). On August 7, 2023, ALJ Kangas mailed a letter to claimant stating that because the appellant questionnaire response was late, it would not be considered, or a new order issued. This matter comes before EAB based upon claimant's July 31, 2023, application for review.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and copies provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) On January 6, 2023, the Department mailed decision # 145517 to claimant at claimant's mailing address of record. Decision # 145517 stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received no later than January 26, 2023." Exhibit 1 at 2. Claimant filed a request for hearing on February 2, 2023.

**CONCLUSIONS AND REASONS:** Order No. 23-UI-230249 is set aside, and this matter remanded for a hearing to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # 145517.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The deadline to file a request for hearing on decision # 145517 was January 26, 2023. Claimant filed their request for hearing on February 2, 2023. Accordingly, the request for hearing was late. In their appellant questionnaire response, claimant asserted that they filed a request for hearing by phone. EAB Exhibit 1 at 1. The response does not indicate whether this occurred prior to the deadline for timely filing. If claimant attempted to file a request for hearing by phone prior to the filing deadline and was unaware that the request was not actually filed, this may constitute a factor beyond claimant's reasonable control or an excusable mistake that prevented timely filing. Further development of the record is therefore needed.

On remand, inquiry should be made into when claimant received decision # 145517, when and how claimant attempted to request a hearing on that decision, and if no attempts were made to file a request for hearing on or before January 26, 2023, what prevented claimant from doing so. Further inquiry should be made into whether claimant's late request for hearing was filed within a "reasonable time" after any factors that prevented timely filing ceased.

For these reasons, Order No. 23-UI-230249 is set aside, and this matter remanded for a hearing to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # 145517.

**DECISION:** Order No. 23-UI-230249 is set aside, and this matter remanded for further proceedings consistent with this order.
