# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1115

Late Application for Review Dismissed Without Prejudice

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On April 7, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work for the weeks including January 10, 2021 through February 13, 2021 (weeks 02-21 through 06-21) and therefore was not eligible to receive unemployment insurance benefits for those weeks (decision # 134856). On April 27, 2021, decision # 134856 became final without claimant having filed a request for hearing. On February 7, 2023, claimant filed a late request for hearing on decision # 134856.

ALJ Kangas considered claimant's request, and on May 25, 2023 issued Order No. 23-UI-226053, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 8, 2023. On June 14, 2023, Order No. 23-UI-226053 became final without claimant having filed a timely response to the appellant questionnaire or application for review with the Employment Appeals Board (EAB). On June 15, 2023, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 23-UI-226053 with EAB. On October 4, 2023, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's June 15, 2023 late application for review of Order No. 23-UI-226053.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's appellant questionnaire response and attachments thereto, claimant's application for review, and the postmarked envelope in which these documents were mailed. This evidence has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On June 15, 2023, the appellant filed an application for review of Order No. 23-UI-226053 with EAB.<sup>1</sup> ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than June 14, 2023. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is October 16, 2023, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review, **as distinct from the reason that they filed the late request for hearing on decision # 134856**. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, how the reason(s) affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: <u>https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx</u>, *or* 

<sup>&</sup>lt;sup>1</sup> Claimant's application was signed with a date of June 12, 2023. EAB Exhibit 1 at 9. However, the envelope in which the application for review was mailed is postmarked June 15, 2023. EAB Exhibit 1 at 10. Under OAR 471-041-0065(1)(b) (May 13, 2019), the filing date of a mailed document is "the date that the document is deposited in the United States mail in an envelope with first class postage, as evidenced by the postmark affixed to the envelope by the United States Postal Service." Because the postmark is dated June 15, 2023, that is the filing date of the application for review.

**DECISION:** The application for review filed June 15, 2023 is dismissed without prejudice. Order No. 23-UI-226053 remains undisturbed.
