EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1124

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 28, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was therefore ineligible to receive unemployment insurance benefits for the week of September 11, 2022, through September 17, 2022 (week 37-22) and until the reason for the denial ended. On October 18, 2022, the September 28, 2022, administrative decision became final without claimant having filed a request for hearing. On January 26, 2023, claimant filed a late request for hearing.

ALJ Kangas considered claimant's request, and on June 7, 2023, issued Order No. 23-UI-227225, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 21, 2023. On June 27, 2023, Order No. 23-UI-227225 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On July 2, 2023, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 23-UI-227225 with EAB. On October 17, 2023, ALJ Kangas mailed a letter to claimant stating that because the appellant questionnaire response was late, it would not be considered, and a new order would not be issued. This matter comes before EAB based upon claimant's July 2, 2023, late application for review.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of the written statement accompanying claimant's late application for review, which was claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 23-UI-227225, mailed to claimant on June 7, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-227225 at 2.

Order No. 23-UI-227225 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than June 27, 2023."

(2) Claimant's application for review was postmarked July 2, 2023. EAB Exhibit 1 at 3.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-227225 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review was July 2, 2023; that date is therefore the filing date.

The application for review of Order No. 23-UI-227225 was due June 27, 2023. Because claimant did not file their application for review until July 2, 2023, the application for review was late. Claimant provided a written statement with the application for review in the form of their response to the appellant questionnaire. However, this written statement addressed only why claimant's request for hearing on the September 28, 2022, administrative decision was filed late, and did not describe the circumstances that prevented claimant from filing the application for review of Order No. 23-UI-227225 on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed July 2, 2023, is dismissed. Order No. 23-UI-227225 remains undisturbed.
