EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1125

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 8, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to provide information in accordance with the Department's rules and therefore was ineligible for unemployment insurance benefits for the weeks of August 7, 2022, through August 27, 2022 (weeks 32-22 through 34-22) and until the reason for the denial had ended (decision # 604081). On September 28, 2022, decision # 604081 became final without claimant having filed a request for hearing. On November 18, 2022, claimant filed a late request for hearing on decision # 604081. ALJ Kangas considered claimant's request, and on March 28, 2023, issued Order No. 23-UI-220311, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 11, 2023. On April 17, 2023, Order No. 23-UI-220311 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 10, 2023, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 23-UI-220311 with EAB. On October 17, 2023, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's July 10, 2023, application for review of Order No. 23-UI-220311.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's July 10, 2023, response to the appellant questionnaire and the postmarked envelope in which it and the application for review were mailed, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-220311, mailed to claimant on March 28, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-220311 at 2.

Order No. 23-UI-220311 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than April 17, 2023."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-220311 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-220311 was due by April 17, 2023. Because claimant did not file their application for review until July 10, 2023, the application for review was late. Claimant provided a written statement with the application for review, by way of the appellant questionnaire response. EAB Exhibit 1. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed July 10, 2023, is dismissed. Order No. 23-UI-220311 remains undisturbed.
