EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1125-R

EAB Decision 2023-EAB-1125 Reversed & Remanded on Reconsideration

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 8, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to provide information in accordance with the Department's rules and therefore was ineligible for unemployment insurance benefits for the weeks of August 7, 2022 through August 27, 2022 (weeks 32-22 through 34-22) and until the reason for the denial had ended (decision # 604081). On September 28, 2022, decision # 604081 became final without claimant having filed a request for hearing. On November 18, 2022, claimant filed a late request for hearing on decision # 604081. ALJ Kangas considered claimant's request, and on March 28, 2023, issued Order No. 23-UI-220311, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 11, 2023. On April 17, 2023, Order No. 23-UI-220311 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 10, 2023, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 23-UI-220311 with EAB. On October 17, 2023, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. On October 23, 2023, EAB issued EAB Decision 2023-EAB-1125, dismissing claimant's late application for review and leaving Order No. 23-UI-220311 undisturbed.

On January 13, 2024, OAH supplemented the record with an appellant questionnaire response that claimant had timely filed on or around April 4, 2023, and returned this matter to EAB. On its own motion, EAB reopened EAB Decision 2023-EAB-1125 for reconsideration. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: EAB Decision 2023-EAB-1125 is reversed and this matter remanded for consideration of claimant's timely appellant questionnaire response.

ORS 657.290(3) authorizes EAB, upon its own motion, to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment

Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019).

On October 23, 2023, EAB dismissed claimant's late application for review of Order No. 23-UI-220311. This dismissal was based in part on claimant having filed only a late response to the appellant questionnaire, which neither required OAH to consider the response nor explained why claimant filed the late application for review. However, in light of OAH's subsequent supplementation of the record, the record now shows that claimant filed a timely response to the appellant questionnaire. Therefore, claimant was entitled to a review of that response to determine if they had good cause for filing the late request for hearing. EAB Decision 2023-EAB-1125 is therefore reversed, and the matter remanded for consideration of claimant's response to the appellant questionnaire.

DECISION: EAB Decision 2023-EAB-1125 is set aside, and this matter remanded for further proceedings consistent with this order.
