## AMENDED EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1130-A

Late Application for Review Dismissed Without Prejudice

NOTE: These amended decisions are being issued solely to correct an error in EAB Decisions 2023-EAB-1130 and 2023-EAB-1131. The correction appears in bold with yellow highlight below.

PROCEDURAL HISTORY AND FINDINGS OF FACT: On August 16, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective December 27, 2020. On September 7, 2021, the August 16, 2021, PUA determination became final without claimant having filed a request for hearing. On November 29, 2022, the Department served notice of an administrative decision, based in part on the August 16, 2021, PUA determination, concluding that claimant received benefits to which they were not entitled and assessing an overpayment of \$6,355 in PUA benefits and \$9,300 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision # 142539). On December 19, 2022, decision # 142539 became final without claimant having filed a request for hearing. On January 25, 2023, claimant filed late requests for hearing on the August 16, 2021, PUA determination and decision # 142539.

ALJ Kangas considered claimant's requests, and on June 7, 2023, issued Orders No. 23-UI-227197 and 23-UI-227199, dismissing claimant's requests for hearing on the August 16, 2021, PUA determination and decision # 142539, respectively, as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by June 21, 2023. On June 27, 2023, Orders No. 23-UI-227197 and 23-UI-227199 became final without claimant having responded to the appellant questionnaire or filing applications for review with the Employment Appeals Board (EAB). On June 29, 2023, claimant filed late responses to the appellant questionnaire and late applications for review of Orders No. 23-UI-227197 and 23-UI-227199 with EAB. On October 17, 2023, ALJ Kangas mailed letters stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue additional orders regarding these matters because the questionnaire response was late. This matter comes before EAB based upon claimant's June 29, 2023, applications for review of Orders No. 23-UI-227197 and 23-UI-227199.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-227197 and 23-UI-227199. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1131 and 2023-EAB-1130).

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's June 29, 2023, response to the appellant questionnaire and the postmarked envelope in which it and the applications for review were mailed, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**CONCLUSIONS AND REASONS:** The applications for review are dismissed without prejudice.

On June 29, 2023, the appellant filed applications for review of Orders No. 23-UI-227197 and 23-UI-227199 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the applications for review to be filed no later than June 27, 2023. The appellant's applications for review are therefore late, and these applications for review are dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is October 25, 2023, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, how the reason(s) affected their ability to file a timely application for review, whether claimant's living circumstances or ability to timely receive mail affected the timeliness of their applications for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*

5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: <a href="https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx">https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx</a>, or

- 4. Send EAB a fax at 503-378-2129.

**DECISION:** The applications for review filed June 29, 2023, are dismissed without prejudice. Orders No. 23-UI-227197 and 23-UI-227199 remain undisturbed.
