EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1134

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 31, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to provide information to the Department and was therefore ineligible for unemployment insurance benefits for the weeks of July 18, 2021, through September 4, 2021 (weeks 21-21 through 35-21) and until the reason for the denial ended (decision # 576070). On February 22, 2022, decision # 576070 became final without claimant having filed a request for hearing. On May 10, 2023, claimant filed a late request for hearing on decision # 576070.

ALJ Kangas considered claimant's request, and on September 21, 2023, issued Order No. 23-UI-236433, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 5, 2023. On October 6, 2023, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 23-UI-236433 with the Employment Appeals Board (EAB). On October 17, 2023, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's October 6, 2023, application for review of Order No. 23-UI-236433.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: Order No. 23-UI-236433 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 576070 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The request for hearing on decision # 576070 was due by February 22, 2022. Because claimant did not file their request for hearing until May 10, 2023, the request was late. On their appellant questionnaire response, claimant stated, "[Decision # 576070] was mailed to me but I never received it that's why I wasn't able to send a hearing request[.]" EAB Exhibit 1 at 1.

If claimant never received decision # 576070, they may have failed to file a timely request for hearing due to factors beyond their reasonable control. However, more information is needed to determine whether claimant's late request for hearing should be allowed. On remand, the ALJ should inquire as to whether claimant was aware of any issues they had been experiencing with mail delivery around the time that decision # 576070 was mailed; if so, what those issues were and if they took any steps to resolve them; whether decision # 576070 was mailed to claimant's correct address and, if not, whether and when claimant updated their address with the Department; when, if at all, claimant eventually received decision # 576070; if not, how they otherwise learned about the decision or its outcome; and whether claimant filed their request for hearing within the seven-day "reasonable time" period after the factors which prevented their timely filing ceased to exist.

Order No. 23-UI-236433 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 576070.

DECISION: Order No. 23-UI-236433 is set aside, and this matter remanded for further proceedings consistent with this order.
