

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1144**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On March 2, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not actively seeking work during the weeks of February 5, 2023, through February 25, 2023 (weeks 06-23 through 08-23) and was therefore ineligible to receive unemployment insurance benefits during those weeks (decision # 132428). Claimant filed a timely request for hearing. On April 10, 2023, the Department mailed notice to claimant of a hearing scheduled for April 17, 2023. On April 17, 2023, ALJ Roberts convened a hearing at which claimant failed to appear, and issued Order No. 23-UI-222248, dismissing claimant's request for hearing due to his failure to appear. On May 2, 2023, claimant filed a timely request to reopen the April 17, 2023, hearing. On September 18, 2023, ALJ Micheletti conducted a hearing, and on September 26, 2023, issued Order No. 23-UI-236739, denying claimant's request to reopen and leaving Order No. 23-UI-222248 undisturbed. On October 11, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-236739 is affirmed.
