

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1148

Affirmed
Ineligible Weeks 29-21 through 30-21 and 32-21 through 35-21

PROCEDURAL HISTORY: On January 31, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's requirements and therefore was ineligible for unemployment insurance benefits for the weeks of July 18, 2021, through July 31, 2021 (weeks 29-21 through 30-21) and until the reason for the denial had ended (decision # 575615). Also on January 31, 2022, the Department served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's requirements and therefore was ineligible for benefits for the weeks of August 8, 2021, through September 4, 2021 (weeks 32-21 through 35-21) and until the reason for the denial had ended (decision # 575616). Claimant filed timely requests for hearing on decisions # 575615 and 575616. On September 18, 2023, ALJ Sachet-Rung conducted a combined hearing on both administrative decisions, and on September 21, 2023 issued Orders No. 23-UI-236512 and 23-UI-236511, modifying decisions # 575615 and 575616, respectively, by concluding that claimant was ineligible for benefits for the weeks of 29-21 through 30-21 and 32-21 through 35-21.¹ On October 11, 2023, claimant filed applications for review of Orders No. 23-UI-236512 and 23-UI-236511 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-236512 and 23-UI-236511. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1148 and 2023-EAB-1147).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-236512 and 23-UI-236511 are affirmed.

¹ The overall outcome of the orders under review was to modify each administrative decision to include the period of weeks covered by the other decision, such that *both* administrative decisions denied claimant benefits for the same two periods of weeks. The orders under review did not find claimant ineligible for any weeks of benefits beyond those originally denied under decisions # 575615 and 575616.
