

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1155**

*Affirmed*  
*Ineligible for Benefits Weeks 27-23 through 29-23 and 31-23 through 34-23*

**PROCEDURAL HISTORY:** On July 19, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information to the Department and was not eligible to receive unemployment insurance benefits for the weeks including July 2, 2023, through July 15, 2023 (weeks 27-23 through 28-23) and until the reason for the denial ended (decision # 142037). Claimant filed a timely request for hearing. On September 20, 2023, ALJ Frank conducted a hearing. The Employment Department submitted an Attestation in lieu of attending the hearing. On September 28, 2023, ALJ Frank issued Order No. 23-UI-237135, modifying decision # 142037 by concluding claimant was not eligible to receive benefits for July 2, 2023, through July 22, 2023, and July 30, 2023 through August 26, 2023 (weeks 27-23 through 29-23 and 31-23 through 34-23). On October 18, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-237135 is affirmed.
