

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1160**

*Affirmed*  
*Late Request for Hearing Allowed*  
*Ineligible for Pandemic Unemployment Assistance*

**PROCEDURAL HISTORY:** On April 8, 2022, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was ineligible for PUA benefits effective February 16, 2020. On April 28, 2022, the April 8, 2022, PUA determination became final without claimant having filed a request for hearing. On May 12, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 30, 2022, issued Order No. 22-UI-201634, dismissing claimant's late request for hearing, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 13, 2022.

On September 19, 2022, Order No. 22-UI-201634 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On December 12, 2022, claimant filed a late response to the appellant questionnaire. On January 11, 2023, ALJ Kangas mailed a letter to claimant stating that because the appellant questionnaire response was late, it would not be considered, and another order would not be issued. On July 11, 2023, claimant filed a late application for review of Order No. 22-UI-201634 with EAB. On August 29, 2023, EAB issued EAB Decision 2023-EAB-0770, allowing claimant's late application for review of Order No. 23-UI-201634, reversing Order No. 23-UI-201634, and remanding the matter for further inquiry as to whether claimant's late request for hearing on the April 8, 2022, PUA determination should be allowed and, if so, the merits of that decision.

On September 14, 2023, ALJ Nyberg conducted a hearing, and on September 28, 2023 issued Order No. 23-UI-237148, allowing claimant's late request for hearing on the April 8, 2022 PUA determination and affirming the PUA determination by concluding that claimant was not eligible for PUA benefits for the weeks of February 16 through December 12, 2020 (weeks 08-20 through 50-20) and December 27, 2020 through June 5, 2021 (weeks 53-20 through 22-21). On October 17, 2023, claimant filed an application for review of Order No. 23-UI-237148 with EAB.

**WRITTEN ARGUMENT:** Claimant filed written arguments on October 17, 2023, and November 19, 2023. EAB considered claimant's October 17, 2023, argument when reaching this decision. Because claimant's November 19, 2023, argument was not received by EAB within the time period allowed under OAR 471-041-0080(1) (May 13, 2019), the argument was not considered by EAB when reaching this decision. OAR 471-041-0080(2)(b).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-237148 is affirmed.
