

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1166

Affirmed
Late Request for Hearing Allowed
Ineligible Week 30-21
Overpayment Assessed

PROCEDURAL HISTORY: On August 4, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the week of July 25, 2021, through July 31, 2021 (week 30-21) and therefore was ineligible for unemployment insurance benefits for that week (decision # 111948). On August 24, 2021, decision # 111948 became final without claimant having filed a request for hearing. On July 13, 2022, the Department served notice of an administrative decision, based in part on decision # 111948, concluding that claimant received benefits to which he was not entitled, and assessing an overpayment of \$231 in regular unemployment (regular UI) benefits and \$300 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision # 105233). On July 20, 2022, claimant filed a late request for hearing on decision # 111948 and a timely request for hearing on decision # 105233.

On October 9, 2023, ALJ Wardlow conducted a combined hearing on decisions # 111948 and 105233. On October 12, 2023, ALJ Wardlow issued Order No. 23-UI-238470, allowing claimant's late request for hearing on decision # 111948 and affirming that decision on the merits. On October 13, 2023, ALJ Wardlow issued Order No. 23-UI-238558, affirming decision # 105233. On October 18, 2023, claimant filed applications for review of Orders No. 23-UI-238470 and 23-UI-238558 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-238470 and 23-UI-238558. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1165 and 2023-EAB-1166).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-238470 and 23-UI-238558 are affirmed.
