# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1173

Affirmed Late Request for Hearing on PUA Determination Dismissed Late Request for Hearing on Overpayment Decision Dismissed Overpayment Waiver Denied

**PROCEDURAL HISTORY:** On June 3, 2022, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not eligible for PUA benefits effective December 6, 2020. On June 10, 2023, the Department served notice of an administrative decision based in part on the June 3, 2022, PUA determination, concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing an overpayment of \$18,290 in combined PUA and Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay, and a \$2,743.50 monetary penalty. On June 23, 2022, the June 3, 2022, PUA determination became final without claimant having filed a request for hearing. On June 30, 2022, the June 10, 2022, overpayment decision became final without claimant having filed a request for hearing. On August 31, 2022, the Department served notice of an administrative decision denying claimant's request for waiver of the overpayment that the Department had assessed on June 10, 2022 (decision # 154401). On September 20, 2022, decision # 154401 became final without claimant having filed a request for hearing.

On February 27, 2023, claimant filed late requests for hearing on the June 3, 2022, PUA determination, the June 10, 2022, overpayment decision, and decision # 154401. ALJ Kangas considered claimant's requests, and on May 23, 2023, issued Orders No. 23-UI-225753, 23-UI-225754, and 23-UI-225755, dismissing the requests as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by June 6, 2023. On June 6, 2023, claimant filed a timely response to the appellant questionnaire. On June 14, 2023, the Office of Administrative Hearings (OAH) mailed letters stating that Orders No. 23-UI-225754, and 23-UI-225755 were vacated and that hearings would be scheduled to determine whether to allow claimant's late requests for hearing and, if so, the merits of the June 3, 2022, PUA determination, the June 10, 2022, overpayment decision, and decision # 154401.

On July 7, 2023, ALJ Lucas conducted a hearing on decision # 154401, and on July 14, 2023, issued Order No. 23-UI-230530, allowing claimant's late request for hearing on decision # 154401 and

affirming that decision on the merits. On July 31, 2023, claimant filed an application for review of Order No. 23-UI-230530 with the Employment Appeals Board (EAB). On September 8, 2023, EAB issued EAB Decision 2023-EAB-0838, modifying Order No. 23-UI-230530 by allowing claimant's late request for hearing on decision # 154401, and setting aside the order as to the merits of decision # 154401 and remanding the matter for further proceedings. At that time, claimant's requests for hearing on the June 3, 2022, PUA determination and the June 10, 2022, overpayment decision remained pending at OAH.

On October 3, 2023, ALJ Lucas conducted a combined hearing on the June 3, 2022, PUA determination and the June 10, 2022, overpayment decision, and a separate hearing on decision # 154401. On October 6, 2023, ALJ Lucas issued Orders No. 23-UI-237917 and 23-UI-237921, dismissing claimant's late requests for hearing on the June 3, 2022, PUA determination and the June 10, 2022, overpayment decision, leaving those decisions undisturbed. Also on October 6, 2023, ALJ Lucas issued Order No. 23-UI-238015, re-affirming decision # 154401 on the merits. On October 20, 2023, claimant filed applications for review of Orders No. 23-UI-237917, 23-UI-237921, and 23-UI-238015 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-237917, 23-UI-237921, and 23-UI-238015. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2023-EAB-1173, 2023-EAB-1174, and 2023-EAB-1176).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-237917, 23-UI-237921, and 23-UI-238015 are affirmed.
