

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1179**

*Affirmed*  
*Late Request for Hearing on Overpayment Decision Dismissed*  
*Overpayment Waiver Denied*

**PROCEDURAL HISTORY:** On January 5, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$23,260 overpayment of combined Pandemic Unemployment Assistance (PUA), Lost Wages Assistance (LWA) and Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay, and a \$3,219 monetary penalty. On January 25, 2022, the January 5, 2022, overpayment decision became final without claimant having requested a hearing. On November 15, 2022, claimant filed a late request for hearing on the January 5, 2022, overpayment decision. On May 11, 2023, the Department served notice of an administrative decision denying claimant's request to waive an outstanding balance of \$22,265 of the overpayment assessed in the January 5, 2022, overpayment decision (decision # 155116). Claimant filed a timely request for hearing on decision # 155116.

On October 9, 2023, ALJ Frank conducted hearings regarding the January 5, 2022, overpayment decision and on decision # 155116, and on October 17, 2023, issued Order No. 23-UI-238745, dismissing claimant's request for hearing on the January 5, 2022 overpayment decision as late without good cause and leaving the overpayment decision undisturbed, and Order No. 23-UI-238743, affirming decision # 155116 on the merits. On October 22, 2023, claimant filed timely applications for review of Orders No. 23-UI-238745 and 23-UI-238743 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-238745 and 23-UI-238743. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1178 and 2023-EAB-1179).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing records, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearings when reaching this decision. EAB considered claimant's argument to the extent it was based on the hearing records.

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-238745 and 23-UI-238743 are affirmed.
