EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1210

Affirmed
No Disqualification

PROCEDURAL HISTORY: On September 7, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by Honda of Beaverton, but not for misconduct, and was not disqualified from receiving benefits based on the work separation (decision # 84453). Honda of Beaverton filed a timely request for hearing. On October 9, 2023, ALJ Adamson conducted a hearing, and on October 10, 2023 issued Order No. 23-UI-238104, modifying decision # 84453 by finding that claimant was never employed by Honda of Beaverton, and claimant therefore was not disqualified from receiving benefits based on a work separation from Honda Beaverton.¹ On October 26, 2023, Honda of Beaverton filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider employer's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-238104 is affirmed.
