

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1212

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 26, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective March 15, 2020 (decision # 75313). Claimant filed a timely request for hearing. On June 14, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing on decision # 75313 scheduled for June 27, 2022. On June 27, 2022, ALJ Mott conducted a hearing at which the employer failed to appear, and on June 28, 2022, issued Order No. 22-UI-196989, reversing decision # 75313 by concluding that claimant was discharged by the employer, but not for misconduct, and was not disqualified from receiving benefits based on the work separation.

On July 15, 2022, employer filed a request to reopen the June 27, 2022, hearing. On September 14, 2023, OAH served notice of a hearing scheduled for September 26, 2023, on whether to allow the employer's request to reopen the hearing and, if so, the merits of decision # 75313. On September 26, 2023, ALJ Sachet-Rung conducted the hearing, and on October 3, 2023, issued Order No. 23-UI-237503, allowing the employer's request to reopen, cancelling Order No. 22-UI-196989, and modifying decision # 75313 by concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective April 19, 2020. On October 23, 2023, Order No. 23-UI-237503 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On October 27, 2023, claimant filed a late application for review of Order No. 23-UI-237503 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant submitted with her application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-237503, mailed to claimant on October 3, 2023, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 23-UI-237503 at 5. Order No. 23-UI-237503 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before October 23, 2023, to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 23-UI-237503 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-237503 was due October 23, 2023. Because claimant did not file her application for review until October 27, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe the circumstances that prevented her from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed October 27, 2023, is dismissed. Order No. 23-UI-237503 remains undisturbed.
