EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1225

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 13, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective November 17, 2019 (decision # 151828). On December 3, 2020, decision # 151828 became final without claimant having filed a request for hearing. On March 28, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on July 1, 2022 issued Order No. 22-UI-197374, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 15, 2022. On July 21, 2022, Order No. 22-UI-197374 became final without claimant having responded to the appellant questionnaire or filed an application for review of Order No. 22-UI-197374 with the Employment Appeals Board (EAB). On November 1, 2023, claimant filed a late application for review of Order No. 22-UI-197374 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence the written statement claimant included with her application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDINGS OF FACT: (1) Order No. 22-UI-197374, mailed to claimant on July 1, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-197374 at 2. Order No. 22-UI-197374 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than July 21, 2022."

(2) On March 25, 2022, the Department served notice of an administrative decision based in part on decision # 151828, concluding that claimant was paid \$8,292 in regular unemployment insurance (Regular UI) benefits and Federal Pandemic Compensation to which she was not entitled and must repay (decision # 164220). Department records indicate that on March 28, 2022, claimant filed a timely

request for hearing on decision # 164220. Department records further indicate that the Office of Administrative Hearings (OAH) has not yet scheduled a hearing on decision # 164220.¹

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-197374 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-197374 was due July 21, 2022. Because claimant did not file her application for review until November 1, 2023, the application for review was late. Claimant included a written statement with the application for review. However, claimant's written statement did not describe circumstances preventing her from filing the application for review on time. The statement instead focused on the overpayment assessed in decision # 164220, on which claimant requested a timely request for hearing on March 28, 2022, which is still pending at OAH. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed. However, claimant may wish to contact OAH and check on the status of her request for hearing on decision # 164220.

DECISION: The application for review filed November 1, 2023 is dismissed. Order No. 22-UI-197374 remains undisturbed.
