

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1237**

*Affirmed*  
*Eligible Weeks 33-23 and 34-23*  
*Ineligible Week 35-23*

**PROCEDURAL HISTORY:** On August 30, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the week of August 13 through 19, 2023 and until claimant registered for work as required. On August 31, 2023, the Department served notice of an administrative decision concluding that claimant was denied benefits for the weeks from August 13 through 26, 2023 and until claimant provided identification verification documentation as required (decision # 122313). Claimant filed a timely request for hearing on both administrative decisions. On October 13, 2023, ALJ Kaneshiro conducted a hearing, and on October 16, 2023 issued Orders No. 23-UI-238676 and 23-UI-238674, modifying the August 30, 2023 administrative decision and decision # 122313 by concluding that claimant was eligible for benefits for the weeks from August 13 through 26, 2023, but was not eligible for benefits for the week of August 27 through September 2, 2023. On November 6, 2023, claimant filed an application for review of Orders No. 23-UI-238676 and 23-UI-238674 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-238676 and 23-UI-238674. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1236 and 2023-EAB-1237).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-238676 and 23-UI-238674 are affirmed.
