EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1242-R

Request for Reconsideration Dismissed EAB Decision 2023-EAB-1242 Remains Undisturbed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 12, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which he was not entitled, and assessing an overpayment of \$13,818 in combined Pandemic Unemployment Assistance (PUA) and Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision # 112832). Claimant filed a timely request for hearing. On October 19, 2023, ALJ Nyberg conducted a hearing, and on October 27, 2023, issued Order No. 23-UI-239791, affirming decision # 112832. On November 8, 2023, claimant filed an application for review with the Employment Appeals Board (EAB). On December 21, 2023, EAB issued EAB Decision 2023-EAB-1242, reversing Order No. 23-UI-239791 by concluding that claimant was not liable for an overpayment of benefits for the weeks at issue in decision # 112832 (weeks 41-20 through 31-21). On January 9, 2024, the Department filed a request for reconsideration of EAB Decision 2023-EAB-1242. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: The Department's January 9, 2024 request for reconsideration is dismissed.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB issued EAB Decision 2023-EAB-1242 on December 21, 2023. The Department filed their request for reconsideration on January 9, 2024, less than 20 days after EAB Decision 2023-EAB-1242 was mailed. However, the Department's request for reconsideration did not include a statement that a copy

of the request for reconsideration was provided to claimant as required. The Department's request for reconsideration therefore is dismissed.

DECISION: The request for reconsideration filed January 9, 2024 is dismissed. Order No. 23-UI-239791 remains undisturbed.
