EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1246

Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On April 27, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective August 2, 2020 (decision # 144451). On May 17, 2022, decision # 144451 became final without claimant having filed a request for hearing. On October 2, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 10, 2023 issued Order No. 23-UI-238215, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 24, 2023. On October 30, 2023, Order No. 23-UI-238215 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On November 10, 2023, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On November 10, 2023, the appellant filed an application for review of Order No. 23-UI-238215 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than October 30, 2023. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is December 15, 2023, *and*

- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received Order No. 23-UI-238215, whether they read it and the reason(s) why they did not file a response to the appellant questionnaire by the October 30, 2023 application for review deadline, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or
- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@employ.oregon.gov, *or*

- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed November 10, 2023 is dismissed without prejudice. Order No. Order No. 23-UI-238215 remains undisturbed.
