EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1250

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On March 16, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and therefore was disqualified from receiving unemployment insurance benefits effective January 15, 2023 (decision # 73737). On April 5, 2023, decision # 73737 became final without claimant having filed a request for hearing. On April 14, 2023, claimant filed a late request for hearing on decision # 73737. ALJ Kangas considered claimant's request, and on October 31, 2023 issued Amended Order No. 23-UI-231959, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 15, 2023. On November 13, 2023, claimant filed a timely response to the appellant questionnaire and a timely application for review of Amended Order No. 23-UI-231959 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's November 13, 2023 response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) On March 16, 2023, the Department mailed decision # 73737 to claimant's address on file with the Department. Decision # 73737 stated, "You have the right to appeal this

¹ Amended Order No. 23-UI-231959 amended Order No. 23-UI-231959, originally issued on August 1, 2023, apparently to correct claimant's mailing address. Although Amended Order No. 23-UI-231959 stated that claimant's response to the appellant questionnaire must be submitted by August 15, 2023, this deadline was apparently a scrivener's error. Claimant had 14 days, until November 15, 2023, to respond to the appellant questionnaire.

decision if you do not believe it is correct. Your request for appeal must be received no later than April 5, 2023." Exhibit 1 at 2.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The request for hearing on decision # 73737 was due by April 5, 2023. Because claimant did not file their request for hearing until April 14, 2023, the request was late. On their appellant questionnaire response, claimant indicated that they received decision # 73737 on March 5, 2023, which was prior to the date of the decision's issuance. EAB Exhibit 1 at 1. Claimant did not provide any information to explain why they failed to file the request for hearing by the timely filing deadline of April 5, 2023. Therefore, claimant has not shown that they filed the late request for hearing due to factors beyond their reasonable control.

Further, although claimant's failure to meet the timely filing deadline was likely the result of a mistake on claimant's part, the record does not show that it was an "excusable mistake" within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Therefore, claimant's late request for hearing on decision # 73737 must be dismissed under ORS 657.875 and OAR 471-040-0010.

DECISION: Amended Order No. 23-UI-231959 is affirmed.
