

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1260

Application for Review Dismissed
No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 30, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause, disqualifying claimant from receiving benefits effective January 19, 2020 (decision # 102751). Claimant filed a timely request for hearing. On June 14, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for June 22, 2021. On June 22, 2021, claimant failed to appear at the hearing, and ALJ Janzen issued Order No. 21-UI-169221, dismissing claimant's request for hearing due to his failure to appear. On July 8, 2021, claimant filed a timely request to reopen the hearing.

On October 12, 2023, OAH served an amended notice of hearing scheduled for October 25, 2023, on whether to grant claimant's request for a reopening and, if so, the merits of decision # 102751. On October 25, 2023, ALJ Enyinnaya conducted a hearing, and on November 2, 2023, issued Order No. 23-UI-240248, granting claimant's request to reopen and reversing decision # 102751 by concluding that claimant was discharged by the employer, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On November 8, 2023, claimant filed an application for review of Order No. 23-UI-240248 with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 23-UI-240248 presents no justiciable controversy and is dismissed.

On November 8, 2023, claimant filed with the Employment Appeals Board (EAB) an application for review of an order that allowed claimant benefits. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 23-UI-240248 is dismissed and Order No. 23-UI-240248 remains undisturbed.

DECISION: The application for review filed November 8, 2023, is dismissed. Order No. 23-UI-240248 remains undisturbed.
