EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1261

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 8, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was therefore ineligible to receive unemployment insurance benefits for the week of February 19, 2023, through February 25, 2023 (week 08-23) and until the reason for the denial ended. On March 28, 2023, the March 8, 2023, administrative decision became final without claimant having filed a request for hearing. On April 19, 2023, claimant filed a late request for hearing.

ALJ Kangas considered claimant's request, and on August 17, 2023, issued Order No. 23-UI-233530, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 31, 2023. On September 6, 2023, Order No. 23-UI-233530 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On October 6, 2023, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 23-UI-233530 with EAB. On November 29, 2023, ALJ Kangas mailed a letter to claimant stating that because the appellant questionnaire response was late, it would not be considered at the Office of Administrative Hearings (OAH), and a new order would not be issued. This matter comes before EAB based upon claimant's October 6, 2023, late application for review.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of the written statement accompanying claimant's late application for review, which was claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) On August 17, 2023, Order No. 23-UI-233530 was mailed to claimant at their street address of record with the Department at that time, and not to claimant's post office box.

Order 23-UI-233530 stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-233530 at 2. Order No. 23-UI-233530 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than September 6, 2023."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-233530 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-233530 was due by September 6, 2023. Because claimant did not file their application for review until October 6, 2023, the application for review was late. Claimant provided a written statement by way of their response to the appellant questionnaire with the application for review. However, although claimant's written statement may describe why claimant filed a late request for hearing of the Department's March 8, 2023, administrative decision, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Claimant stated that they were unable to access their post office box, and had their mail transferred to their street address. EAB Exhibit 1 at 1. However, Order No. 23-UI-233530 was mailed on August 17, 2023, to claimant's street address, and not to claimant's post office box. Because Order No. Order No. 23-UI-233530 was mailed to claimant's street address, claimant's difficulties with their postal office box did not contribute to claimant's failure to file the application for review on time, by September 6, 2023. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed October 6, 2023, is dismissed. Order No. 23-UI-233530 remains undisturbed.
