EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1275

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 4, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not actively seeking work during the weeks including March 5, 2023, through March 25, 2023 (weeks 10-23 through 12-23) and was therefore ineligible to receive unemployment insurance benefits during those weeks (decision # 132007). On April 24, 2023, decision # 132007 became final without claimant having filed a request for hearing. On April 25, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on September 7, 2023, issued Order No. 23-UI-235362, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 21, 2023. On September 27, 2023, Order No. 23-UI-235362 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On September 28, 2023, claimant filed a late response to the appellant questionnaire and a late application for review with EAB. On November 30, 2023, ALJ Kangas mailed a letter to claimant stating that because the response to the appellant questionnaire was late, it would not be considered, and another order would not be issued. This matter comes before EAB based upon claimant's September 28, 2023 late application for review.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review, dated September 27, 2023, and a copy of the envelope in which the application for review was received, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-235362, mailed to claimant on September 7, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-235362 at 2. Order No. 23-UI-235362 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than September 27, 2023."

CONCLUSIONS AND REASONS: The late application for review of Order No. 23-UI-235362 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review was September 28, 2023; that date is therefore the filing date.

The application for review of Order No. 23-UI-235362 was due September 27, 2023. Because claimant did not file their application for review until September 28, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented them from filing the application for review by the September 27, 2023, deadline. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed September 28, 2023, is dismissed. Order No. 23-UI-235362 remains undisturbed.
