EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1276-R

Request for Reconsideration Dismissed

PROCEDURAL HISTORY: On September 9, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective August 7, 2022 (decision # 151307). Claimant filed a timely request for hearing. On October 13, 2022, the Office of Administrative Hearings served notice of a hearing scheduled for October 21, 2022. On October 21, 2022, ALJ Ainardi conducted a hearing at which the employer failed to appear, and on October 28, 2022, issued Order No. 22-UI-206156, reversing decision # 151307 by concluding that claimant was discharged, not for misconduct, and was not disqualified from receiving benefits based on the work separation.

On November 1, 2022, the employer filed a timely request to reopen the October 21, 2022, hearing. On September 20, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for November 3, 2023, on whether to grant the employer's request to reopen and, if so, the merits of decision # 151307. On November 3, 2023, ALJ Nyberg conducted the hearing, and on November 9, 2023, issued Order No. 23-UI-240924, granting the request to reopen, but reversing decision # 151307 by concluding that claimant was discharged, not for misconduct, and was not disqualified from receiving benefits based on the work separation.

On November 19, 2023, the employer filed an application for review of Order No. 23-UI-240924 with the Employment Appeals Board (EAB). On January 3, 2024, EAB issued EAB Decision 2023-EAB-1276, affirming Order No. 23-UI-240924. On January 21, 2024, the employer filed a request for reconsideration of EAB decision 2023-EAB-1276. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

FINDING OF FACT: The employer's request for reconsideration of Order No. 2023-EAB-1276 did not include a statement that a copy of the request was provided to claimant.

CONCLUSIONS AND REASONS: The employer's request for reconsideration of Order No. 2023-EAB-1276 is dismissed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

The employer's request for reconsideration of Order No. 2023-EAB-1276 is dismissed because it did not include a statement that a copy of the request was provided to claimant, as required under OAR 471-041-0145(2).

DECISION: The request for reconsideration filed January 21, 2024 is dismissed. Order No. 23-UI-240924 remains undisturbed.
