EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1279

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 27, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able to work or actively seeking work from April 15 through September 18, 2021 and was denied benefits for that period and until the reason for the denial had ended (decision # 151340). On October 18, 2021, decision # 151340 became final without claimant having filed a request for hearing. On November 16, 2021 claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on February 3, 2022 issued Order No. 22-UI-185509, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 17, 2022. On February 10, 2022, claimant filed a timely response to the appellant questionnaire. On April 22, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 22-UI-185509 was vacated and that a hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # 151340.

On September 8, 2023, OAH served notice that the hearing was scheduled for September 22, 2023. On September 22, 2023, ALJ Enyinnaya conducted the hearing, and on September 29, 2023 issued Order No. 23-UI-237311, allowing claimant's late request for hearing as with good cause, and modifying decision # 151340 by concluding that claimant was not eligible for benefits for the weeks from August 15, 2021 through May 28, 2022 (weeks 33-21 through 21-22). On October 19, 2023, Order No. 23-UI-237311 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On November 19, 2023 claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement included with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-237311, mailed to claimant on September 29, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-237311 at 5. Order No. 23-UI-237311 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 19, 2023 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-237311 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-237311 was due October 19, 2023. Because claimant did not file his application for review until November 19, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed November 19, 2023 is dismissed. Order No. 23-UI-237311 remains undisturbed.
